## Addendum No. 1

### BACKFLOW PREVENTER INSTALLATION PROJECT CF-01016

#### BIDDERS

The following addendum amends and is hereby made as part of the contract documents for the Backflow Preventer Installation Project CF-01016. **The primary purpose of this addendum is to replace the Bid Form and provide additional clarity on miscellaneous items.**

#### SPECIFICATIONS

**Proposal Forms (pages P-2 through P-5)** – Replace in its entirety with the attached 4 pages (pages P-2 through P-5) dated March 27, 2018. The proposal form has been updated to include a total of 42 backflow units, where originally it was 62.

**Notice to Contractors (page N-2 item 6)** – Replace the paragraph in its entirety with the following:  
**Contractor's License:** The Contractor is required to have a valid State of California **General Contractor's License Class B** or Plumbing Contractor License Class C-36 for this work. All bidders shall be licensed under the provisions of Chapter 9, Division 3 of the Business and Professions Code of the State of California to do the type of work contemplated in the project.

Note that a license classification of C-27 is not allowed to perform work on this project.

**City Licenses and Permits (page SP-1) – Add the following as clarification to this paragraph:**

A building permit will not be required by the Contractor to do the work; however, in work locations affecting traffic, an approved Lane Closure Permit shall be obtained by the Contractor. The City will waive permit fees.
